Mrs. Cote wishes to share her public transport concept idea for the Town of Hearst in order to resolve the taxi dilemma in the community. Presently, citizens are inconvenienced due to the lack of public transportation and many organizations and businesses had to take individual initiatives to bridge this shortage. Her idea is to create a collective public transportation system with the people of Hearst; Hearst Transpo.

The Town of Hearst, through the Economic Development Corporation and different community partners, could create a Transportation Department comprised of municipal community vehicles for public transportation for a variety of needs of citizens. This approach would serve individuals, companies and organizations to meet the social, health, business and tourism needs while contributing to the operation of various services and improving the quality of life of citizens.
