i) Amendment to the financial incentive for recruitment of doctors

Marylène Tremblay-Comeau, Recuitment Coordinator, Notre-Dame Hospital Re: presentation of the 2017 recruitment report

Mrs. Tremblay-Comeau presents her report, a copy which is appended hereto.

In response to questions from members of Council, Mrs. Tremblay-Comeau responds as follows:

- The greatest challenge is the retention;
- College Boréal has made cutbacks in the nursing program in response to the decrease of students and smaller centres like Hearst are the ones suffering from the consequences;
- The implication of municipalities would certainly help in political efforts for the reinstatement of nursing programs in the area;
- We must prepare in anticipation of the retirement of several doctors;
- The hospital is still trying to recruit a general surgeon;
- Incentives are offered to nursing students, including nursing practitioners, not only for doctors;
- Young doctors are now also looking at the social aspect of what a community has to offer;
- Approximately 30 students graduate each year in the North Bay/Sudbury nursing programs, versus 40 to 50 in past years;
- A partnership with Hôpital Montfort is a great idea but psychiatrists need to be on board.

The Mayor thanks Mrs. Tremblay-Comeau for her presentation and congratulates the team for their hard work.
