#### > Personal Emergency Leave

Personal emergency leave is job-protected time off work for up to 10 days per calendar year. The first two days of personal emergency leave must be paid. This leave may be taken for personal illness, injury or medical emergency. #### 4. A. Presentation: Tammy Larouche from Victims Services (see annex A)

Victim services or VCAO is a community-based service that employs staff and trained volunteers to provide in case of crisis, intervention services, information and referral services to victims of crime and tragedy 24 hours a day, 7 days a week. This

service is funded by the Ministry of the Attorney General and works in partnership with the Ontario Provincial Police and other community services.

## **B. Presentation: Joelle Ayotte from Habitat Interlude** (see annex B)

Woman abuse can take different forms; physical abuse, psychological abuse, sexual abuse, economic or financial abuse and spiritual abuse. Every woman has the right to be safe and live without fear.
