THE CORPORATION OF THE TOWN OF HEARST

BY-LAW NO. 59-15

(as amended by By-laws 80-15 and 56-2020)

Being a by-law to permit and regulate the operation of off-road vehicles on municipal highways

WHEREAS Section 191 of the Highway Traffic Act, R.S.O. 1990, c. H.8, as amended, provides that the council of a municipality may pass by-laws permitting and regulating the operation of off-road vehicles on any highway within the municipality that is under the jurisdiction of the municipality, or on any part of such highway, and

WHEREAS it is deemed advisable to permit and regulate the operation of certain offroad vehicles on certain municipal highways,

NOW THEREFORE, BE IT ENACTED by the Council of the Corporation of the Town of Hearst as follows:

1. **Definitions:**

For the purpose of this by-law:

- B-L 56-2020 1.1 "All-terrain vehicle" has the same meaning as in Ontario Regulation 316/03 Operation of Off-Road Vehicles on Highways of the Highway Traffic Act.
- B-L 56-2020 1.2 "Extreme terrain vehicle" has the same meaning as in Ontario Regulation 316/03 Operation of Off-Road Vehicles on Highways of the Highway Traffic Act.
 - 1.3 "Highway" includes a common and public highway, street, avenue, crescent, road, place, parkway, driveway, square, lane, bridge, viaduct or trestle, any part of which is intended for or used by the general public for the passage of vehicles and includes the area between the lateral property lines thereof.
- B-L 56-2020 1.4 "Multi-purpose off-highway utility vehicle" has the same meaning as in Ontario Regulation 316/03 Operation of Off-Road Vehicles on Highways of the Highway Traffic Act.
 - 1.5 "Municipality" in this by-law, a reference to the municipality is a reference to the geographical area, or to the municipal Corporation of the Town of Hearst, as the context requires.
- B-L 56-2020 1.6 "Off-road motorcycle" has the same meaning as in Ontario Regulation 316/03 Operation of Off-Road Vehicles on Highways of the Highway Traffic Act.
- B-L 56-2020 1.7 "Off-Road Vehicle (ORV)" has the same meaning as in the Off-Road Vehicles Act.
 - 1.8 "Operator or driver" means every person who drives an off-road vehicle upon a highway, trail or road.
- B-L 56-2020 1.9 "Recreational Off-Highway Vehicle" has the same meaning as in Ontario Regulation 316/03 Operation of Off-Road Vehicles on Highways of the Highway Traffic Act.

- 1.10 "Regulation" means the regulations, laws and provisions established under the Ontario Regulation 316/03, Highway Traffic Act and Off-Road Vehicle Act of Ontario.
- 1.11 "Sidewalk" means that portion of a street between the curb lines or lateral lines of a roadway and the adjacent property lines intended for the use of pedestrians.

2. Rules of Operation for Off-Road Vehicles

- Off-road vehicles (ORV), including all-terrain vehicles, multi-purpose off-highway utility vehicles, recreational off-highway vehicles, extreme terrain vehicles and off-road motorcycles that meet the requirements of Ontario Regulation 316/03 of the Highway Traffic Act may be driven on roads within the Town of Hearst municipal boundaries, except on the following streets:
 - **George Street**, from 8th Street to 9th Street;
 - Ninth Street, from Front Street to Prince Street;
 - **Edward Street**, from Ninth Street to Fifteenth Street (during school hours only);
 - Alexandra Street, from Ninth Street to Tenth Street (during school hours only);
 - **Veilleux Street**, from Mailloux Street to Rouse Street (during school hours only).
 - 2.2 No person shall operate an ORV:
 - in municipal parks,
 - in municipal cemeteries,
 - on the municipal waste lagoon property,
 - on the Notre-Dame Hospital property,
 - on the Foyer des pionniers/Pioneer Nursing Home property
 - on school properties,
 - on the Collège Boréal property, and
 - on the Université de Hearst property.
 - 2.3 No person shall operate an ORV on a trail that is designed and posted as a non-motorized trail, other than along a designated travel route to facilitate access to a traditional area or to cross a non-motorized trail at a right angle to access a shared-use trail upon which ORV use is permitted.
 - 2.4 No person shall operate an ORV on a sidewalk or other area specifically designed for pedestrian and cycling traffic.
 - 2.5 The speed limit shall not exceed 20 kilometers per hour on any road where the posted speed is 50 km/h and 50 kilometers per hour when the posted speed is more than 50 km/h.
 - 2.6 No person shall operate an ORV in such a manner that causes or is likely to cause:
 - a risk to the safety of any person,
 - harm or material discomfort to any person from dust, emissions or noise.
 - harm, injury or damage, either directly or indirectly, to any property, flora or fauna,
 - alteration, disruption or destruction to the natural environment, including erosion damage or degradation of the right of way.
 - 2.7 No person shall operate an ORV on a designated snowmobile trail unless authorized specifically in writing.
 - 2.8 An ORV operator shall operate an ORV in a single file only.

- 2.9 Despite any section in this By-law, no person shall operate an off-road vehicle on a highway in contravention to Ontario Regulation 316/03 of the Highway Traffic Act, R.S.O. 1990, c. H.8.
- 3. This By-law may be enforced by any By-law Enforcement Officer.
- 4. A person who contravenes any of the provisions of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act, R.S.O. 1990, c P.33.
- 5. THAT By-laws No. 39-04, 05-05 and 35-05 be hereby repealed.
- 6. THAT this by-law shall be in effect at the time of its adoption.
