

THE CORPORATION OF THE TOWN OF HEARST

BY-LAW NO. 90-2022

Being a by-law to provide for Councillors
to be appointed Acting Mayor for the period
of November 15, 2022 to November 14, 2026

WHEREAS Article 242 of the Municipal Act, 2001 authorizes a municipality to appoint members of the Council to act in the place of the Head of Council when the Head of Council is absent or refuses to act, or the office is vacant, and while so acting, such members have all the powers and duties of the Head of Council, and

NOW THEREFORE, BE IT ENACTED by the Council of the Corporation of the Town of Hearst as follows:

1. THAT members of Council of the Corporation of the Town of Hearst be and are appointed to act, from time to time, in the place of the Mayor when absent from the Municipality or absent through illness, or his Office is vacant, in the following order:
 - a) November 15th, 2022 to January 14th, 2023: Josée Vachon
 - b) January 15th, 2023 to March 14th, 2023: Gaëtan Baillargeon
 - c) March 15th, 2023 to May 14th, 2023: Daniel Lemaire
 - d) May 15th, 2023 to July 14th, 2023: Nicolas Picard
 - e) July 15th, 2023 to September 14th, 2023: Martin Lanoix
 - f) September 15th, 2023 to November 14th, 2023: Joël Lauzon
 - g) November 15th, 2023 to January 14th, 2024: Josée Vachon
 - h) January 15th, 2024 to March 14th, 2024: Gaëtan Baillargeon
 - i) March 15th, 2024 to May 14th, 2024: Daniel Lemaire
 - j) May 15th, 2024 to July 14th, 2024: Nicolas Picard
 - k) July 15th, 2024 to September 14th, 2024: Martin Lanoix
 - l) September 15th, 2024 to November 14th, 2024: Joël Lauzon
 - m) November 15th, 2024 to January 14th, 2025: Josée Vachon
 - n) January 15th, 2025 to March 14th, 2025: Gaëtan Baillargeon
 - o) March 15th, 2025 to May 14th, 2025: Daniel Lemaire
 - p) May 15th, 2025 to July 14th, 2025: Nicolas Picard
 - q) July 15th, 2025 to September 14th, 2025: Martin Lanoix
 - r) September 15th, 2025 to November 14th, 2025: Joël Lauzon
 - s) November 15th, 2025 to January 14th, 2026: Josée Vachon
 - t) January 15th, 2026 to March 14th, 2026: Gaëtan Baillargeon
 - u) March 15th, 2026 to May 14th, 2026: Daniel Lemaire
 - v) May 15th, 2026 to July 14th, 2026: Nicolas Picard
 - w) July 15th, 2026 to September 14th, 2026: Martin Lanoix
 - x) September 15th, 2026 to November 14th, 2026: Joël Lauzon
2. THAT where a member of Council appointed to act as Mayor pursuant to Section 1 is absent or refuses to act, the next appointed member will be solicited to act as Head of Council.
3. THAT By-law No. 98-2021 be hereby repealed.
